Navy is concerned about ships and may foster a separate study that considers the research community's need for research vessels that will compliment their needs. Mentioned the JIOST(?) Studies are conducted to advise the NAS.

Education Committee Report

Report (45pp) was sent via email and will discuss tomorrow in general session. Student award portion of the report presented. Discussed awards given last year; indicated that the information is given at the end of the report. There was a request that we produce a certificate for Ocean Science winners that would contain SAML, ASLO and AFS acknowledgements...Matt would then sign and send the awards, also would give opportunity to include a SAML congratulatory letter on SAML letterhead and a sales pitch for consideration of SAML labs for future jobs.

Discussion by Bob VanDolah requesting if ERF was dropped as potential recipient for student awards; discussion indicated that ERF was not openly receptive, wanted the award to be given to general ERF fund; Bob VD will champion the interaction. Motion carried unamonously.

Treasurer's Report

2007 Financial Report, attached sheet.

Motion to accept report (Jim Morris); 2nd (Bob VD), vote unanimous for approval. Discussion: Note that Kumar closed SAML bank account and shifted funds to NAML/SAML account in Dec 2007. Kumar discussed the history of SAML related to the treasurer's role; Kumar inherited paperwork from Harold? in Mississippi; filing taxes first in MS then in FL...discovered that we were not established as a non-profit, but acting as a trade organization. Kumar was advised by financial advisor that SAML should be filing on earned income. Early days of SAML as org. discussion went back and forth on being a non-profit and it is assumed that the MS contingent decided to not file for non-profit. Since we are part of a national organization that has 501C status, NAML, we could just file under their umbrella. It was decided at the NAML meeting that SAML would come under the NAML umbrella, by moving our funds to them, while maintaining our functional autonomy. Does bring up the need to change the bylaws...might want to rename the operating procedures for SAML since come under the NAML by-laws. Essentially NAML by-laws were drafted from SAML by-laws, with addition of one paragraph referring to regional organizations. Decision we can incorporate in State of Florida and retain our by-laws and non-profit status; or just move under NAML. Wes, Kumar, Jim S and Alan K will form committee to make decision that will keep Federal Labs in the mix. NAML by-laws should be clear on the fact that the regional organizations have control over their own activities and funds. Wes explained the cost of the Skidaway meeting...to improve attendance and promote involvement we decided to support food/hotel for 3 years.

Financial Committee Audit Report

Roger Z and Bill Hawkins reviewed the Financial Report; see signatures on the Financial Report. Roger stated all seemed to be in order; suggested that typo—2005 to 2006 be fixed, dues payable.

Discussion: All dues paid to NAML and SAML portion returned to SAML. 42 labs out of 60 are paid. Interpretation of what a marine lab is has changed, especially since we need to increase our membership to support NAML efforts...departments and programs may be included.
