2017 Business Meeting Minutes
22 May 2017

The Annual Business meeting of SAML was called to order by President Aswani Volety at 11:05 a.m. (Eastern Time).

Martin Posey, Director of UNCW Center for Marine Science, provided an overview of the host lab. This was followed by updates from member institutions.

- **Minutes Approval:** The 2016 Business meeting minutes had been posted on the SAML web site. The minutes were approved by acclamation.
- **Membership Approval:** Texas A&M University-Corpus Christi, represented by Ed Proffitt: Eric Milbrandt made the motion to accept TAMUCC as a SAML member and Rick DeVoe seconded. Acceptance of TAMUCC as members approved by acclamation.

- **Audit Committee Report (Eric Milbrandt for Joel Thompson)**

Committee members: Joel Thompson, Eric Milbrandt, Michael Parsons, and Robert Dickey. The Audit Committee reviewed the financial records provided by Treasurer Dave Eggleston and reported that all transactions were appropriately documented for 2016. There were no questions. Read Hendon moved (seconded by Eric Milbrandt) for approval of the Audit Committee Report. The motion passed by acclamation.
- **Nominating Committee Report (Lou Burnett)**

Members: Louis Burnett, Felicia Coleman, Read Hendon. Felicia Coleman nominated as Member at Large for a term beginning in January 2018 to replace Linda Schaffner. There were no other nominations. The appointment of Felicia Coleman as Member-At-Large was approved by acclamation. Dave Eggleston was nominated as President Elect for SAML (2018-19) for term beginning 2018. The appointment of Dave Eggleston as President Elect for SAML was approved by acclamation.

Names put forth for Treasurer to replace Dave Eggleston and (Joseph Read Hendon) and Secretary (Sue Ebanks) as recommendations from the Nominating Committee. This appointment process will be handled by President Quint White. Robert Dickey was put forth as the nominee from SAML for the NAML President-elect for SAML's rotation on NAML President. The appointment of Robert Dickey as President Elect for NAML was approved by acclamation.

- Lou Burnett reviewed the NAML/SAML website/pages (<http://naml.org> and <http://saml.naml.org>), providing the password and solicited attendees to add their jobs, opportunities, & courses, and to send their pictures for the scroller to Sue or him. Also publicized the SAML Student Support program (<http://saml.naml.org/members/studentssupport.php>). Attending members, specifically Rick DeVoe & Mona Behl suggested student competition to for the development of a SAML logo
- **Motion for Naming of Student Travel Award proposed by Lou Burnett (seconded by Kumar Mahadevan).** After discussion regarding rotation of naming convention, the motion for naming of Student Travel Award was carried by unanimous acclamation (Appendix 3). **Kumar Mahadevan's** name was put forward and approved for 2018. Margaret Davidson's name was put forward by Rick DeVoe for consideration by the Executive Committee for the name of the next award. The suggestion was made that if there are two names, the Executive Committee should consider having the award named for both.
